37. To establish, maintain or grant aid for the establishment and/or maintenance of parks, gardens, gymnasiums, sports clubs, dharma shala's and rest houses, for use by public in general.
38. To establish, maintain or grant aid to special homes for the aged, destitute children, orphanages, children with AIDS, street children, helpless women in poor economic conditions or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons.

41. The trust will be empowered to collect donations, grants, and subscriptions, loans from any person, Government agency, Bank or organization of national or international origin for the purpose of the trust.

A. It shall be lawful for the Trustees to receive by way of gifts, grants, bequests, donations, contribution, movable and immovable properties and legacies from any persons, firms, associations, Trusts, Co-operative, corporate or Government/ Semi Government bodies, authorities, undertakings or establishments whether towards corpus of the trust or otherwise, for all or any of the objects/purposes of the Trust herein created upon and / or subject to such special conditions as may be attached thereto but not in any way at variance with the purposes or objects of this Trust, and to retain any investments or other properties so received as an addition to the Trust Corpus if so required as a condition and to apply the same upon or subject to such conditions but otherwise in accordance with the provisions herein contained. However, all investment made or retained by the Trust shall be in accordance with the provisions for Income Tax Act 1961.

B. The Trustee shall have power by supplementary declaration(s) resolution(s) of the Board to amend, delete or alter any of the objects set out hereinabove or any matter provided in the Deed as may be determined by two-third majority of the Trustees and/ or to the extent such amendments, declarations or deletions be required by the Commissioner of Income-tax or any other competent tax authority in order that the Trust be eligible and continue to be eligible for the various exemptions and privileges granted to Public Charitable Trusts under the Income-tax Act, 1961 and/ or under any other Indian Tax Statutes for the time being in force.

5) TRUSTEES:

- A.** All the trustees including the Settlor who are in office from time to time shall be referred to collectively as the 'Board of Trustees'.
- B.** The Trustees will not be entitled to receive any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
- C.** The Settlor for the time being will be at liberty to appoint additional Trustees within in the number mentioned above for such period or on such terms as to retirement and reappointment as the trustees for the time being consider proper. A person shall cease to be a Trustee either:
- if he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year, whichever is longer, or
 - if he is requested to resign by 3/4th or as near thereto as possible of the remaining Trustees.
- D.** Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.
- E.** The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees.
- F.** Three Trustees shall form a quorum for a meeting of the Trustees.
- G.** All matters will be decided mutually by the Trustees.
- H.** Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.

- I. The Trust and the Trust Funds shall be and irrevocable for all times.

2. The Chairman shall have the custody and control of the documents of title to the properties of the Trust, accounts and

3. The Chairman shall be agree to appoint Chief Executive Officer of the Trust's project.
4. To demand and receive money due to the Trust and issue receipt for the money so received.
5. To open and operate bank account or accounts in the name of the trust and projects independently or jointly with other trustees as the board of trustees decide.
6. To make, draw, endorse, accept, sign, negotiate or transfer cheque, promissory notes, hundies, bills of exchange, bills of lading, railway receipts and other negotiable or transferable instruments, Government securities or other securities.
7. With the approval of the Commissioner / Director of Income tax To lease out for a period not exceeding three years at a time, lands and properties of the Trust which are ordinarily leased out if there is a statutory or Government department requirement of a longer period of lease, the lease may be for a longer period as per such requirement and on specific resolution of the Board of Trustees.
8. To initiate, prosecute, defend, compromise, refer to arbitration and/or abandon legal proceedings or disputes and to sign all papers in connection therewith.
9. To appoint, employ, remunerate, remove, suspend, discharge, dismiss, re-employ, replace, transfer and accept resignations of staff and workers permanently or temporarily.

✓ **SECRETARY:**

✓ **TREASURER:**

The Treasurer is authorized to sign bank cheques, application for drafts and payment instructions jointly with the Chairman and draw money from the bank, up to the limits defined by the Board of Trustees in their meetings. The Treasurer is responsible for safe custody of cash, bonds, securities etc. of the Trust.

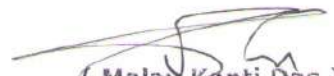
